3. All bookings will only be confirmed upon receipt of final payment.
4. If you cancel your booking within 7 days of signing this priority booking form a cancellation fee equal to 30% of the cost of the package is immediately payable by you. No cancellations will be accepted after 7 days.
5. Package confirmation is subject to the availability of the requested facility. ECG makes no representations or warranties that the package will be available at the time of booking. All packages and events are subject to the availability and in the event that a package is unavailable at the time of booking, ECG will refund all monies paid by the client in respect of the package sought.
6. While we do our best to ensure your package arrangements are of the highest possible standard; we cannot accept any responsibility for the cancellation of or changes to the event or for the acts, omissions or errors of those over whom we have no direct and exclusive control.
